A Notice of Award to the successful Bidder will be issued with 4 weeks of public reading. If a bid is to be awarded, FWBG will award the Contract within 90 days of the bid opening unless extended in writing. When BRIT issues contract documents following a Notice of Award, Contractor shall sign and deliver the required number of copies and all required additional documentation within 14 days.
